Course Description:

This course is centered on cultivating an understanding of futures literacy and developing its practical application within design disciplines. The course focuses on the principles and methodologies of futures literacy - an essential 21st century skill defined by UNESCO - empowering students to critically anticipate future design trends and possibilities. Adopting an approach of practice first, theory later, design last, the course will guide participants to a theoretical and practical understanding of futures literacy through hands-on workshops, collaborative discussions, and scenario building.

Online Delivery

This course will take place **online via and Zoom for the first 4 days** (Feb 12-15), and **in person on the last day** (Feb 16th). **Desire2Learn (D2L) will be used for project submissions.** Students are required to participate in the synchronous Zoom and in person sessions. Students will be

expected to have their cameras on during the online sessions, and actively participate in discussions.

If unable to participate live due to unforeseen circumstances, inform the instructor in advance to work out an alternative participation activity (watch the recordings, submit a brief reflection, and actively contribute to the follow-up online discussion).

Course Learning Outcomes:

Upon completion of this course, students will:

- 1. Develop a solid understanding of what futures literacy entails and better incorporate diverse perspectives, experiences, and values into design work.
- 2. Learn to apply critical and creative thinking to explore and construct multiple future scenarios in the field of architecture.
- 3. Enhance their communication skills through articulating complex and abstract futures concepts through various media.

Technology requirements:

Assessment Components:

Students will be graded primarily on their participation throughout the week, demonstrating their engagement with the exercises and content, and thoughtfully providing feedback to their peers. The final project will be assessed based on how effectively critical thinking and creative design were applied to future scenarios, the quality of the students' presentation of the content, and the clarity of the documented process.

Assessment and Evaluation Information Attendance and Participation Expectations:

Students are expected to attend every class during the block week class. This course is mainly evaluated on participation, including producing or preparing content necessary for discussion and contributing to individual and class-wide discussions and/or conversations/assessments with the Course Instructor.

Excused Absences: In the event of an exceptional circumstance (e.g., illness, bereavement, etc.) or an exceptional opportunity (e.g., varsity athletic competition, national conference or awards ceremony, pow wow, etc.) **up to one excused absence is allowable** in the duration of the block week before jeopardizing one's own course grade and ability to pass the course. However, any such accommodations must be approved by the instructor with advance notice by the student.

Unexcused Absences: Attendance and **participation in all class sessions is mandatory**. Unexcused absences are grounds for failure in the course.

Guidelines for Submitting Assignments:

Final projects will be presented on Friday, February 16th, and must be digitally submitted on D2L by 6pm that day.
