Course Description

This course will explore the role of building codes and bylaws on design. We will undertake an in-depth analysis of the building code and the land use bylaw, describing each of their roles and how they are different from each other. Students will be asked to work through a series of case study examples of projects located in different cities. As part of the course, students will be taken on a site visit where PPE (Personal Protective Equipment) will be required.

The course will be delivered in-person. A zoom link can be provided should someone feel unwell and is unable to attend in person.

Course Hours: March 13 – 17, 2023, 9:30am-3:30pm with a break from 12 – 1pm daily

Course Learning Outcomes

Upon completion of this course, students will know and be able to:

- 1. Describe the difference between the land use bylaw and the building code.
- 2. Given a specific site, determine the land use designation as per the land use bylaw.
- 3. Understand the development guidelines and restrictions on a site.
- 4. Given a building type, determine the code classification and high-level code requirements.
- 5. Independently complete a bylaw and high-level code analysis for a case-study site.
- 6. Identify bylaw and code regulations applied to existing buildings and buildings under construction
